We are a high end wine and cocktail bar, we would like to offer a takeaway service of packaged liquor. The liquor we would be looking to supply takeaway would be limited to bottles of wine and pre batched cocktails that we currently offer at the bar. Allowing people access to rare and hard to access wines we are able to source from suppliers. It will also allow customers to take away a small experience from our bar in the form of a pre batched cocktail with instructions as to how to serve and garnish at home.

We do not wish to act as a bottle shop but more as a venue that offers an extra experience over other venues in the area.
