## Mandatory dog de-sexing for non-breeding dogs

Excessive and unnecessary. The current problems are the unscrupulous people who breed crossbreds deliberately in order to make as much money as possible without regard for any hereditary problems or temperament. If people want to de-sex their dogs that is their choice. I am especially against mandatory de-sexing of very young dogs because of the health problems this causes. I own a bitch and a dog (Shetland Sheepdogs) both of which are de-sexed, but that was my choice.

Many competitive sporting dogs belong to people who, whilst they are not registered breeders, may want to have a puppy from their dog because of its outstanding ability in competition. I really cannot see any reason to take this opportunity away from owners. Working dogs are also dogs that do not necessarily belong to registered breeders and once again, a good working line is something that needs to be protected.
