- 2. Sale of packaged wine for takeaway. To cater for the large number of domestic and international visitors who visit the iconic Freemantle markets, we will offer for sale twin packs of WA home grown wines from regions including Swan Valley, Margaret River, Great Southern. Payments will be completed at point of sale via credit/debit cards. Stock will be held on premises in a secured cabinet.
